SUBJECT: Soccer parking and fence security - Fields of Uxbridge

BACKGROUND:

The Fields of Uxbridge has seen some major upgrades in the past four years and parking and field security have always been a high priority.

With numerous grants coming in for the Fields of Uxbridge we have been able to:

1. Build a baseball diamond (2021)
2. Build a lit Parking lots with accessible paths (2021)
3. Irrigate two senior soccer fields (spring 2022 completed)
4. Lights two soccer Fields (fall 2022)
5. Light the Pump Park and the Skate Park (fall 2022)
6. And increase safety to the property with additional fencing and gates.

As part of field security, a series of fencing was proposed at the back of the property in consultation with the soccer club. Parking at the back was re-access with participants safety as its higher priority, follow by field safety and user experience. This plan is in line with the **Fields of Uxbridge Master Plan** done in 2016 and is part of a grant for the Fields of Uxbridge focused on improving safety and the user experience.

DISCUSSION:

Scope of Work:

- Supply and Install Approx. 830m of 2 Rail Cedar Wood Fence
- Supply and Install 736 m2 of Gravel Parking
- Supply and Install 10m Entrance Gate

The installation will include all materials, labour, equipment, environmental and site protection measures and approvals necessary to complete the work to the satisfaction of the Township of Uxbridge.

Tender #U22-19 closed on May 26th, 2022. We had 27 bid takers and 10 bids that were submitted for evaluation.

The tender amount of \$59,118.00 (excluding HST) from Environmental Contracting Ontario Inc. fits within the budget and will be 100% funded by one of the grants earmarked for safety/user experience at the Fields of Uxbridge. A provisional item for additional fence per meter from ECO is set at \$55.00/m. This can be added if more boundary protection is needed. An additional focus for this section of the property will be to avoid ATV/snowmobiles entering the property and damaging our new assets.

The Township of Uxbridge has used Environmental Contracting Ontario Inc. (ECO) for other projects and references were checked for additional information.
