KAREN FISHER, BOARD MEMBER, DURHAM REGION POLICE SERVICE BOARD re Annual Community Policing Report

Ms. Karen Fisher, Board Member of the Durham Region Police Service Board presented with the assistance of a power point presentation. Ms. Fisher, along with Police Chief Peter Moreira presented on behalf of the Police Board.

Ms. Fisher explained that the purpose of the presentation is to give an update on policing services in Durham Region, as well to establish more regular dialogue on community safety, priorities and concerns within communities. The Board committed to this engagement by connecting with the elected representatives who are the closest to our citizens.

Ms. Fisher explained that, as a result of changes to the Community Safety and Policing Act, there has been additional responsibilities to the Police Board. Ms. Fisher informed that policies and strategic plans, and Board meeting recordings are published to the Durham Regional Police Services website, and Ms. Fisher encouraged Council and the public to review that information.

Ms. Fisher identified that the current areas of focus are the Board's strategic plan as well as implementation of Community Safety; Policing Act Regulations; Budget 2025 and Community Engagement.

Ms. Fisher spoke about an Information and Education Session invitation which will be coming out shortly for November from the Police Board.

Ms. Fisher discussed the main areas of focus for community safety issues as items related to firearms, auto theft, mental health and crimes against seniors and children.

UMKULTHOOM ELHASSAN re Fire invoice for a motor vehicle accident

Ms. Elhassan addressed Council to dispute a fire charge of \$535.00 for a car accident of June 9, 2024, noting the financial burden such charges would present. Ms. Elhassan requested that Council reconsider the charges as she herself did not request emergency services.

Mayor Barton advised Ms. Elhassan that this Council have never reduced these types of charges.

Fire Chief MacDonald addressed Council to provide details regarding the call, noting that the call came in at 6:25am on Sunday, June 9 at the Uxbridge/Pickering Townline. Chief MacDonald noted that, pursuant to standard procedure, two vehicles were sent out to attend. After it was determined that there was no need for extraction and no substances were leaking, the crew left the scene. A total of 20 firefighters responded to the firehall and 11 responded to the scene of the accident.

Chief MacDonald explained that the nine members not responding remained at the firehall in case a secondary call occurred while others were attending to this matter, which was located a significant distance from the firehall. Chief MacDonald explained that once the call is cleared, all attending firefighters return home.

Councillor Popp thanked the Ms. Elhassan for her presentation but reminded her that this Council have never reduced a fire services invoice.

Ms. Elhassan was provided with the option of a payment plan which would be arranged with the Treasury Department.

re AMCTO Recommendations for Updates to the Municipal Elections Act

Moved by Councillor Popp

WHEREAS elections rules need to be clear, supporting candidates and voters in their electoral participation and election administrators in running elections;

WHEREAS legislation needs to strike the right balance between providing clear rules and frameworks to ensure the integrity of the electoral process;

WHEREAS the legislation must also reduce administrative and operational burden for municipal staff ensuring that local election administrators can run elections in a way that responds to the unique circumstances of their local communities;

WHEREAS the *Municipal Elections Act, 1996* (MEA) will be 30 years old by the next municipal and school board elections in 2026;

WHEREAS the MEA sets out the rules for local elections, the *Assessment Act, 1990* and the *Education Act, 1990* also contain provisions impacting local elections adding more places for voters, candidates, and administrators to look for the rules that bind the local democratic process in Ontario;

WHEREAS with rules across three pieces of legislation, and the *MEA* containing a patchwork of clauses, there are interpretation challenges, inconsistencies, and gaps to fill;

WHEREAS the Act can pose difficulties for voters, candidates, contributors and third-party advertisers to read, to interpret, to comply with and for election administrators to enforce;

WHEREAS while local elections are run as efficiently and effectively as can be within the current legislative framework, modernization and continuous improvement is needed to ensure the Act is responsive to today's needs and tomorrow's challenges;

WHEREAS to keep public trust and improve safeguards the Act should be reviewed considering the ever-changing landscape which impacts elections administration including privacy, the threats of foreign interference, increased spread of mis/disinformation and the increased use of technologies like artificial intelligence and use of digital identities;

WHEREAS the Association of Municipal Managers, Clerks, and Treasurers of Ontario (AMCTO) reviewed the Act and has provided several recommendations including modernizing the legislation, harmonizing rules, and streamlining and simplifying administration;

AND WHERAS AMCTO put forward recommendations for amendments ahead of the 2026 elections and longer-term recommendations for amendments ahead of the 2030 elections;

THEREFORE BE IT RESOLVED THAT The Township of Uxbridge calls for the Province to update the MEA with priority amendments as outlined by AMCTO before Summer 2025 and commence work to review and re-write the MEA with longer-term recommendations ahead of the 2030 elections;

AND THAT this resolution will be forwarded to all municipalities in Ontario for support and that each endorsement be then forwarded to the Minister of Municipal Affairs and Housing (minister.mah@ontario.ca), the Minister of Education (minister.edu@ontario.ca), the Minister of Public and Business Service Delivery (todd.mccarthy@ontario.ca), Minister of Finance (Minister.fin@ontario.ca), the Premier of Ontario (premier@ontario.ca), MPP Peter Bethlenfalvy (Peter.Bethlenfalvy@pc.ola.org), and AMCTO (advocacy@amcto.com).
