We are writing to invite you or a representative from your organization to participate on the Duffin Creek Water Pollution Control Plant Advisory Committee. The objective of the Advisory Committee is to conduct consultation on the implementation of the Phosphorous Reduction Action Plan Study (PRAP).

The Advisory Committee is intended to be comprised of representatives from agencies, municipalities, and a local interest group. We ask that one representative from your organization become a member of the Advisory Committee.

It is intended that the Advisory Committee will meet approximately two to four times a year for the term of the project and three years following operation of the PRAP. Members of the Advisory Committee will be expected to participate in all meetings and represent their respective organizations.

The first Advisory Committee meeting will be scheduled in January or early February of 2020. A formal agenda will be issued prior to the meeting. Further, the mandate of the Advisory Committee will be documented in a Terms of Reference, of which a draft will be circulated prior to the first meeting for discussion. Meetings will be held at the Region of Durham's Headquarters in the Town of Whitby.
