As you are aware, Miller Paving Limited (Miller) has been working with both the Township of Uxbridge and the Ministry of Natural Resources and Forestry (MNRF) to find the best way to manage the M3-1 and M5-1 lands in the south west corner of the above-mentioned property (subject lands). Multiple meetings have occurred over the last number of years, and it was agreed that the subject lands would be surrendered from the Aggregate Resources Act (ARA) licence by the MNRF and the Township would assume responsibility through a site plan approval process. This has required applications by Miller to both agencies, which included reports, detailed design and peer review for the Township application.

MNRF has just advised us that the application to surrender the subject lands will be a major site plan amendment, and as a result we are required to circulate notice of this application to the Township and provide opportunity for you to comment.

The details of the application are as follows:

- Remove the subject lands from the licenced area (36 ha);
- The subject lands would then fall under site plan control, governed by the Township of Uxbridge under the Planning Act; and
- The approvals would occur at the same time.

We understand that you are well aware of this application, particularly the details of the Site Plan Control application. However, should you have any comments or questions regarding the ARA site plan amendment to surrender these lands, please provide them to the following MNRF contact by March 23, 2020, with a copy to us.
